

AMENDMENT TO ORDINANCE #274

ON THIS, the 14th day of September, 2010, the City Council of the City of Bronte, Texas, convened in Regular Session at the regular meeting place thereof in the City Hall, with the following members present, towit:

Mayor Gerald Sandusky, Councilmembers Buzz Gohman, Paula McWright and Jim Guthrie

Mayor Sandusky introduced the proposed amendment to Ordinance #274 of the City of Bronte, Texas. The Ordinance and the proposed Amendment were read in full.

Councilmember Gohman moved the amendment to Ordinance #274 be adopted. Councilmember McWright seconded the motion. The motion carried by the following votes:

Mayor Sandusky announced that the Amendment to Ordinance #274 had been passed.

THE AMENDMENT TO ORDINANCE #274 IS AS FOLLOWS:

ORDINANCE #274 of the City of Bronte, Texas, is hereby amended as to Section G and Section I to read as follows:

SECTION G COLLECTION CHARGES

(a) Premises used for private residences, single or double unit apartment houses, single mobile home sites and/or locations, shall be charged \$14.20 per family unit as to occupied residences, apartments, and units. One polycart container will be provided for each trash service location. Additional containers will be provided for an addition cost of \$9.00.

(b) Premises used for commercial business, and/or public purposes not receiving sanitation container service as described herein shall be charged \$15.77 per month. One polycart container will be provided. Additional containers will be provided for an additional cost of \$9.00.

(c) Premises located outside the City Limits shall be charged at a rate of 1.5 times above the rate charged the City by its trash collection provider. Said premises must be served by another City utility for which a bill is sent.

(d) If polycart if lost or damaged by the resident, a \$60.00 replacement fee will be assessed.

SECTION I CONTAINERIZED SANITATION SYSTEM:

(1) After the effective date of this ordinance, certain public, private, business and/or commercial locations and sites, including the City of Bronte are to receive sanitation container system service for the removal of garbage and trash under the rates and rules hereinafter set forth. Pursuant to the sanitation container system services, the City of Bronte will furnish a container or containers to be used in the collection and/or removal of garbage and trash. The following formula shall be used as to the fees charged for garbage and/or trash hauling to-wit:

Charges per month:

| Container Size | Rate |
|------------------|----------|
| 2 yd. (1 x week) | \$ 63.34 |
| 4 yd. (1 x week) | \$100.71 |
| 6 yd. (1 x week) | \$134.95 |
| 8 yd. (1 x week) | \$169.19 |

This Ordinance Amendment supersedes any previous Amendments to the Section G and Section I.

IT IS FURTHER ORDAINED that said Amendment shall be effective as of September 20, 2010 Billing.
