Mayor Gohman report no action from the executive session.

3. Citizen Comments - Any citizen wishing to appear before a regular meeting of the City Council may do so by signing up to speak at the City Council meeting itself, with regard to any item posted on the City Council agenda. Council may take comments from citizens on the matter. Citizens are allowed three minutes for comments. (Note: Audio recordings of all open session meetings can be requested)

Paul Knight – Regarding Lease deal with Loyd. No transparency and no discussion in public. Addressing the Mayor, Mr. Knight asked about the promise of transparency. Attorney Hogg answered Mr. Knight by saying the executive session was to update the Council on the active litigation against the City. All discussions are attorney/client privilege and discussion in public could give away his strategic defense and he advised the Council not to discuss in Public about the case. Knight asked how Councilmember Lee Wommack is able to go into executive session since he represented Ronny Loyd previously? Conflict of Interest? Lee Wommack commented and said he is not representing Loyd. Attorney Hogg stated that no public comment can be made since no agenda item of discussion/action was on the agenda.

Marlene Vaughn - I have a comment about a house on the corner of Barclay and SW Railroad St. Felma Evans house is going to be put up for sale and the lot next door is ridiculous. It needs to be cleaned up or something done to it. I do not know who the owners are but possibly you can get this from the court

house in Robert Lee. It hasn't been touched, it is an eye sore. Mr. Knight said Rob Trussel possibly owns it.

#### 4. **Discuss – Public Safety:** Fire Department Report

Chief DeLaGarza presented the report. Three more applicants have asked to join the VFD since the house fire. Materials are being bought to start the offices inside the station. This new station is not just for the VFD but for the community; the community is welcome to use it, including. Chief DeLaGarza received a call from a retired fire fighter from Kansas and offered free training. Training will be in September. Additional training will be done for our younger fire fighters in San Angelo for 2 days in October, and then second part of training for fire fighters will be done in November. It is exciting. We received a grant for bunker gear for 10 fire fighters and received \$4k from United Way for wild land gear to fight grass fires. Spray foam insulation is doing great and is a life saver. Added thank you to the community for the overwhelming support.

Mayor Gohman commented how the fire department has evolved over the last several years, amazing and accomplishing so much, with a community of this size such is a miracle and he gave his appreciation.

Citizen Bruce Vaughn commented that the VFD did an excellent job on the house fire. Got there quick, it could have easily spread. We are a small town and we got to do what we got to do to save the community and save the people. Attendance of citizens clapped.

Teresa Ballard presented the Animal Services Report.

Mayor Gohman reported somewhat of an issue, when citizens surrender a dog it costs the City a lot of money to take animals to Brownwood. Teresa Ballard reported the cost is \$25 to surrender a dog and mileage is \$100.

#### 8. Discuss/Act – Code Enforcement: Building Permits

Re-submit - Donna Hall - 121 W Main; Small storage building

Ricky Royall reported to council that we discussed this last month, and now she has moved the little, small building to the other side by the carport and away from the other building where it was sitting at. Ricky sees no issues. Stormy asked if this was a permanent permit or 6 months for a portable building? Yes, this is for a permanent permit.

Discussion from Stormy with concerns about how many people are going to start moving into their business? So, say we have all the living quarters or portable building behind businesses on Main Street when we are trying to re-do Main Street, say everyone decides to live in the businesses on Main Street, what do we do for business? Do we have a business district and a residential district? Ricky Royall reports the only district we have is the fire zone area in downtown, and that anyone can have a business in town anywhere they want to, and anyone can just about live where ever they want to. Stormy Vaughn reports if we don't have anything in place she would like to see this permit as not a permanent permit but for only 6 months until we can look into this further. I don't want this to turn into a loft project when we are trying to get businesses down there. It is okay to help someone get on their feet, but don't see this as a permanent thing.

Santiago Rodriquez reports San Angelo has an ordinance that so many buildings per square footage per property. Is this something could look into it?

Mayor Gohman said yes, we could look into it.

Stormy says that the square footage back in the back of the building is not very big in the first place and if we let Donna do it, then we will have to let all the other do it. That is my concern.

Ricky Royall's recommendation to do a six month permit and relook at it then. Right now, there is no ordinance to keep someone living in their business. In a fire zone they have to abide by certain things but it doesn't keep them from living there.

Lee Wommack says it isn't a bad looking building. Stormy says that if you give to one, you have to give to another and say the next one isn't as nice as Donna's.

Stormy Vaughn recommends a temporary permit for a portable building for 6 months.

Motion by Stormy Vaughn to make it a six month permit on the small storage building at 121 W Main with seconded by David Bedford.

Approved for 6 months only. Resubmit in 6 months.
