Finance: Audit

Megan Solsbery, auditor from Eckert CPA went over the Annual Financial Report Year Ended September 30, 2019 to council. Page three starts Independent Auditor's Report. On pages three through seven is management's discussion and analysis you will have a particularly good understanding what took place this year. There were three findings (see page 48 for detail).
