The auditors make revenue accruals each year which are eight journal entries they must make. What we are doing is recording the transactions as they occur. What we are doing now is saving time and money so the auditors will not have to make as many journal entries, therefore, their fee should be lower. This accounting system is not easy to work with but I want council to consider a major over haul to the Asyst accounting system to having only one bank account, one general ledger. Teresa Ballard will get more information and cost to change to one general ledger or get a new software system.
