 EDC representative Marlene Vaughn reported EDC4B didn't meet this month. Nothing to report at this time.
- 21. Discuss Lawsuit Ronny Loyd vs. City of Bronte

Mayor Gohman gave an over view of the case. TML was the indemnity insurer and they took control of the case and they called for mediation on January 8, 2019. In mediation we got to a number that TML could support

that would not cost the city anything. So TML chose to settle through mediation. The law suit is done. Mayor went on to say, we have been muzzled this whole time. Mayor then turned the floor to Councilman Vaughn.

Stormy Vaughn (Summarized minutes being stated) the whole deal with Loyd and this Lease was a mess and the current Council dealt with the case as best as they could.

- Prior to the Lease being terminated in December 2016, City Hall had contacted the Texas Municipal League stated that they could not help with the claim.
- Settlements from Loyd ranging from \$16k, \$30k, \$21,900, and the last demand for \$60k had been received.
- Council's hands were tied and legally could not give anything of value to Loyd including the settlements he was looking for.
- 4. No proof was provided for any settlement offer that was acceptable. The only proof that we ever received was regarding the Sea Container. A Bill of Sale was produced from Loyd to Ken & Linda Scott in which Loyd sold the container to them. The Council knew that the City did not purchase the Sea Container and we could not legally keep it.
- 5. The Council decided to contact TML again. We had new evidence of the dealings with the Lease.
- 6. The TML Risk Pool stating that if a lawsuit was filed, to contact them again, and they would cover the claim up to a certain point.
- Lawsuit was then filed by Loyd and sued for \$100k-\$200k.
- TML covered the fees of the appointed TML Attorney in the case.
- At this point, it was out of the City of Bronte's hands and TML decided if the case would be settled or not and it went through mediation.
- 10. The Mayor stated that he was at the mediation and an amount was agreed upon by TML and Loyd. TML Insurance paid a settlement amount (\$15,000) that was acceptable to both parties and he was there to make sure no funds for the settlement came from City of Bronte funds.
- 11. The City Secretary said that fees including the deductible for insurance coverage were a total of \$48,000.00. \$43,000 of the attorney's fees was prior to the TML Attorney being appointed and the City of Bronte's coverage under the insurance.

Councilman Hines mention that from the signal light to each city limit sign, is approximately averages 6 tenths of a mile and we have 29 livestock permits. That's a lot in the city limits.

Ricky Royall has approved all the permit request and has concerns with the following three properties; Juan DeLaRosa; Tiffany Harendt and Tim Siler.

- Mr. Siler's property is in the Southland Terrance. This addition has deed restrictions. Mr. Royall's recommendation is to give him 60 days to have the livestock removed. Stock show should be over by then.
- o Tiffany Harendt property; Mr. Royall's reports they are just in a bad spot. It's near the entrance to the cemetery. Council discussed maybe if they put up a privacy wood fence (like out front of the house) with all four sides and not use the perimeter fence of the cemetery. Recommendation to approve with stipulations. Need to give 60-days to 90 days correct the issue, but until then, they need to contain the chickens/quineas. They will need a permit for the fence. If she doesn't comply with recommendation, then chicken/guineas will need to be removed. If she wants the permit, she can come up with a plan with what she can do and if council accepts the plan. Council recommends Ricky Royall to talk to Ms. Harendt and redressed this permit at next council.
- Juan DeLaRosa property; Ms. DeLaRosa reported that they have been trying to keep the area clean, but they
 have had family health matters going on. Council recommends giving them 60 days to clean up the property
 and review again at March council meeting.
- Roping area needs to remove the pig from the property and from the permit request.

Mayor Gohman is looking for a motion with no commercial pigs at the roping area, 210 Lombard for 60 day temporary, tabling for 30 days at 515 So. Franklin and 60 days at 108 Driftwood with notice of restrictions. Stormy Vaughn made a motion to approve all the livestock with the exceptions of the temporary permits, seconded by Santiago Rodriguez.

AN ORDINANCE OF THE CITY OF BRONTE, TEXAS REPEALING AND REPLACING ORDINANCE NO. 298; ADOPTING "CURFEW HOURS FOR MINORS"; DEFINING TERMS: CREATING HOURS FOR CURFEW FOR MINORS; CREATING OFFENSES FOR MINORS, PARENTS OF MINORS, AND BUSINESS ESTABLISHMENTS VIOLATING CURFEW REGULATIONS; PROVIDING FOR ENFORCEMENT; PROVIDING FOR A PENALTY OF UP TO \$500 FOR EACH OFFENSE; MAKING VARIOUS FINDINGS AND PROVISIONS RELATED TO THE SUBJECT; CONTAINING A SEVERABLITY CLAUSE; REPEALING ALL OTHER ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR PUBLICATION AND PROVIDING THAT THIS ORDINANCE SHALL BE EFFECTIVE FROM AND AFTER JANUARY 31, 2019. Mayor Gohman opened public hearing for applying for a Texas Community Development Block Grant (TxCDBG) grant application at 7:55pm.

Councilman Bedford, read the following:

The City is considering applying for a Texas Community Development Block Grant (TxCDBG) grant application. Approximately nine million (\$9,000,000.00) dollars are available through the Texas Department of Agriculture. The main objective of this program is to improve public facilities/infrastructure in order to meet basic human needs, principally for low and moderate-income persons.

Eligible activities include water system improvements, sewer system improvements, community service centers, affordable housing, road and street improvements, drainage improvements, fire protection, handicapped accessibility, and solid waste disposal. The City has been funded in the past through the TxCDBG program in order to make significant infrastructure improvements.

There were no citizen's comments

Mayor Gohman closed the public hearing for applying for a Texas Community Development Block Grant (TxCDBG) grant application at 7:56pm.

Lee Wommack would like this to be tabled until Ricky Royall has a change to review information given to him. Tabled
