- 2) Applicant agrees that this indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the state of Texas, and that if any portion is held invalid, the remainder shall, notwithstanding, continue in full legal force and effect.
- 3) This indemnity agreement contains the entire agreement of the undersigned and the City of Bronte, and may not be modified or altered without the express written consent of the City of Bronte.
- 4) This indemnity agreement shall be constructed in accordance with Texas law and is performable for all purposes in the County of Coke, State of Texas.
